INVITATION FOR EXPRESSION OF INTEREST (EOI)

**Artist / Agency for developing the Float of Industries & Commerce Department in
connection with Onam Celebration 2018**

The Department of Industries & Commerce, Government of Kerala propose to develop a Float in the Onam Pageantry scheduled to be held at Thiruvananthapuram on August 30, 2018 (Thursday).

Requirements

- To develop the theme structure of the Float attractive to common public.
- To set up the developed structure in lorry and to be road showed in the pageantry
- To provide illumination lights, fuel for the lorry etc. in the onam pageantry.
- To accompany the Float in the pageantry
- To provide the basic requirements for the Float in the pageantry
- Green protocol to be maintained in the float
- The float to be completed in all aspects and to be brought to the designated point at Kowdiar by 10.00 AM of August 30, 2018 positively.

Eligibility Criteria

- The Artist / Agency should have undertaken similar kinds of work earlier
- The Artist / Agency to have office OR representative at Thiruvananthapuram

Evaluation Criteria

The selection process of the Artist / Agency will be as below.

1. Short listing based on the design furnished in the Committee scheduled to be held at the Directorate of Industries & Commerce, 3rd Floor, VikasBhavan, Thiruvananthapuram on August 16, 2018 (Thursday) at 11.00 AM.
2. **Price bid have to be submitted by the qualified short listed Artist / Agencies, in sealed envelope, on August 16, 2018. The price bids of only technically qualified Artist / Agency will be considered, which will be informed immediately after the design selection.**

The selection of the Artist / Agency is subject to the approval of the Selection Committee and Kerala Bureau of Industrial Promotion (K-BIP) / Government of Kerala. The Artist / Agency shall ensure carrying out all the activities mentioned in the requirements.

The EoI superscribed 'EoI for Onam Pagentary – Float of Industries & Commerce Department' with proof of documents as mentioned in the Eligibility Criteria shall be submitted to **the Chief Executive Officer, Kerala Bureau of Industrial Promotion (K-BIP) at the address mentioned below on or before August 14, 2018 (Tuesday) by 11.00 AM.**
