ORDER

As per the Government Order read 1st above, an amount of ₹1,57,02,129/- has been resumed from the PSTSB account of HDCK Ltd on 31.03.2020, which includes the amount received for Various projects. As per the Government Orders read 2nd, 3rd and 4th above, an amount of ₹75 lakhs has been re-credited and also as per the Government Order read 5th above sanction has been accorded for releasing an amount of ₹14,60,641 to HDCK.

2. As per the letter read 6th above, the Managing Director, Handicrafts Development Corporation has requested to release the balance amount of resumed fund of Rs. 67,41,488/- at the earliest so as to release the payment of KEL (for the installation of a transformer at the newly constructed building at SMSM Institute), renovation work of Kairali, New Delhi and cluster related (CFSC) payments, etc.

3. Government have examined the matter in detail and are pleased to release an amount of ₹ 10,39,359/- (Rupees Ten lakh thirty nine thousand three hundred fifty nine only) under the h/a 2851-00- 104-86 (Plan) to HDCK against the fund resumed from their PSTSB Account for paying the pending works , subject to the following conditions:-

- i) The release should be transfer credited to PSTSB account in compliance of GO(P) No 62/2018/Fin dated 16.04.2018.
- ii) The amount shall be transfer credited to PSTSB A/c in compliance of GO(P)62/2018/Fin dtd.16.04.2018, GO (P)88/2018/Fin

iii)The procedures prescribed in Circular No.84/08/Fin dated, 09-12- 2008and Circular No.75/09/Fin dated, 29/08/2009, Circular No 8/2018/Fin dated 30/31/2018 and circular 53/2018/fin dated 16.6.2018 should be scrupulously followed.

iv) The Director of Industries and Commerce should strictly furnish the Utilization Certificate in respect of the fund released during the last and current financial years in due course as per the Annexure appended with Go(P) No 04/2020 dated 09.01.2020.

4.The Director/Additional Director of Industries and Commerce will draw and disburse the amount as mentioned above.
