ORDER

Kerala State Agency for Expansion of Cashew Cultivation (KSACC) was allocated an amount of ₹ 715 lakh (Rupees Seven Hundred and Fifteen Lakh Only) in the State Budget for the financial year 2022-23 for the plan proposal 'Cultivation of Organic Cashew and Establishment of Raw Nut Bank' under H/A '2852-08-600-90 (Plan)'. As per the letter read as 1st paper above, the Special Officer (Cashew) & Chairman, KSACC has requested Government to accord Administrative Sanction for ₹ 715 lakh (Rupees Seven Hundred and Fifteen Lakh Only) for the said project.

2)The Departmental Working Group meeting held on 10/05/2022. recommended the proposal for issuance of Administrative Sanction for an amount of ₹ 715 lakh (Rupees Seven Hundred and Fifteen Lakh Only) by meeting the expenditure from the Head of Account '2852-08-600-90' subject to the condition that a comprehensive report incorporating details such as funds spent on each scheme for the last five years period, production increased during each year, productivity achieved, increase in area of cultivation, number of farmers newly entered in cashew farming etc should be submitted to

Government before furnishing proposal for fund release.
