### ORDER

As per Government Order read as 1st paper above, Shri A.Alexander IAS (Rtd) was appointed as Chairman & Managing Director of Kerala Cashew Board Limited for a tenure of three years. In the Order, it was also stipulated that the salary, allowances and other service conditions of CMD shall be fixed as per Rule 100 of Part III KSRs (Revised Vide G.O(P) No.159/2016/Fin dated 19.10.2016). Further, Chairman & Managing Director, Kerala Cashew Board Limited, vide letter read as 2nd paper above, requested Government to issue necessary orders for fixing his pay and allowances for his re-employment in Kerala Cashew Board Ltd.

2) Government have examined the matter in detail and are pleased to fix the re-employment pay of Shri.A.Alexander IAS (Rtd) in the post of Chairman & Managing Director, Kerala Cashew Board limited as under:

The Re-employment Pay = (Basic Pay-Pension)+31% DA on Re-employment pay +18% HRA on Last Pay (rate applicable to the AIS officers).

Last Basic Pay = ₹ 1,26,600/-

Basic Pension = ₹ 63,300/-

The Re-employment Pay = (1,26,600-63,300)+(63,300X31/100)+ (1,26,600x18/100)= 63,300+19623+22788=₹1,05,711/-

3) Shri.A.Alexander IAS (Rtd), CMD, KCB Ltd shall not be eligible for any other allowances other than that specified above.
