### ORDER

Administrative Sanction for Rs.25 lakhs for E-Governance implementation in KADCO -Phase II from the current year's budget provision was accorded as per G.O read above. The Managing Director, KADCO furnished fund release proposal vide letter read above.

2.Government have examined the matter in detail and are pleased to release an amount of Rs.25 lakhs (Rupees Twenty Five lakhs Only) to KADCO for the project 'E-Governance implementation in KADCO-Phase II' under the scheme "Assistance to Apex Organisations in Handicrafts Sector" under the h/a No.4851-00- 104-99(P) subject to the conditions specified in the G.O read above and also to the following terms and conditions of fund release.

1)The amount shall be transfer credited to PSTSB A/c in compliance of G.O(P)No.62/2018/Fin dated 16.04.2018.

2)Funds shall be utilised for the purpose for which it is released and not diverted for any other purpose.

3)Circular No.75/09/Fin dated 29/08/2009, Circular No.8/2018/Fin dated 30.01.2018, Circular No.53/2018//Fin dated 16.06.2018, G.O(P)No.88/2018/Fin.

dated 11.06.2018 and G.O(P)No.100/2018/Fin. dated 03.07.2018 should be followed strictly & the amount that can be spent during the current Financial Year only shall be drawn.

4)The Utilisation Certificate for the whole amount released should be furnished in due course in the prescribed proforma as appended with G.O(Ms)No.04/2020/Fin dated 09/01/2020.

5)The filing fee for ROC and other connected expenditure arising due to enhancement of the authorised capital shall be met by the company from its internal resources and government will not provide any fund on this.

4.The Director/Additional Director of Industries and Commerce will draw and disburse the amount as mentioned above.
