ORDER

As per the letter read as Ist paper above above, the Special Officer (Cashew) & Chairman, Kerala State Agency for Expansion of Cashew Cultivation (KSACC), Kollam has requested Government to grant permission for purchasing a new vehicle or to rent an e-vehicle through ANERT for the usage of Cashew Special Office in view of the vehicle being used by the Office was found uneconomical by Public Works Department. The Special Officer has also requested Government for financial assistance in terms of hiring charges of the motor vehicle.

2.Government have examined the matter in detail and are pleased to release an amount of ₹ 3,03,000/- (Rupees Three lakh and Three Thousand only) which has been additionally authorized vide Government Order read above as one year's advance payment [May 2022- March 2023] under the H/A "2230-01-102-97-97 NP - for the hire charges of motor vehicles" to hire a Tata Nexon EV from ANERT for the usage of the Special Officer (Cashew) and Chairman, Kerala State Agency for Expansion of Cashew Cultivation (KSACC), Kollam strictly subject to the condition that timely steps shall be taken to regularise this additional expenditure through re-appropriation of savings only within the Grant before the close of the current financial year.



3. The Director of Industries and Commerce/Additional Director of Industries and Commerce is entrusted to draw and disburse the said amount to Kerala State Agency for Expansion of Cashew Cultivation (KSACC), Kollam.
