As per letter read above, the Director of Industries and Commerce submitted proposal for various programmes under the new scheme namely 'Local Economic Development and Sustainability of Enterprises' for implementation in the current financial year 2023-2024 under the Head of Account 2851-00-102-98 and requested to accord administrative sanction for the Scheme.

2) The details of the Scheme are given below.

- (b) Implementing agency : Directorate of Industries and Commerce.

3) The Special Working Group in its meeting held on 06.05.2023 considered the proposal and recommended to issue Administrative Sanction for the Scheme of Local Economic Development and Sustainability of Enterprises with the project component - Industry Internship Programme for Promotion of Enterprises in the state during the year 2023-24 for an amount of Rs.32,12,92,000/-(Rupees Thirty Two Crore Twelve Lakh and Ninety Two Thousand only) under the Head of Account 2851-00-102-98(P) from plan fund limiting the expenditure to the current year's budgetary allocation.

4) Government have examined the matter in detail and are pleased to accord Administrative Sanction for the Scheme of Local Economic Development and Sustainability of Enterprises with the project component - Industry Internship Programme for Promotion of Enterprises in the state during the year 2023-24 for an amount of Rs.32,12,92,000/-(Rupees Thirty Two Crore Twelve Lakh and Ninety Two Thousand only) as proposed in the letter read above and duly approved by the Special Working Group as per paper read as 2nd above. The expenditure in this regard will met from the Head of Account 2851-00-102-98(P) limiting the expenditure to the current year's budgetary allocation subject to the following conditions.

(a) Payment to CMD for the selection process of interns (Enterprise Development Executives) may be limited to Rs.25 Lakh (Rupees Twenty-five Lakh only)

(b) A brief report on the newly created 1 lakh MSME units during last year (2022-23) regarding production, achievement, employment, output etc should be forwarded to Finance (Planning) Department.

5) The Director of Industries and Commerce will draw and disburse the amount in due course ensuring that the following general conditions should be followed wherever applicable.

- (a) The expenditure would be met from the budgetary provision available under the appropriate Head of Account.
- (b) The fund release will be based on actual requirement and the fund released should not be parked in banks.
- (c) Store Purchase Rules shall be strictly adhered to wherever applicable
- (d) Tender/e-tender and other stipulated formalities shall be followed wherever necessary.
- (e) Post creation and purchase of vehicles are not admissible under the scheme.
- (f) For hiring of project staff/man power as part of project implementation, instructions issued in GO(P)No.76/2019/Fin. dated 02.07.2019 and GO(P)No.81/2019/Fin dated 09.07.2019 shall be followed.
