ORDER

As per Government Orders read as 1st & 2nd papers above, administrative sanction was accorded for an amount of ₹218 lakhs to the Handicrafts Development Corporation of Kerala Ltd. (HDCK) against the total project cost of Rs. 383 lakhs for the project- New product development, Office automation, virtual exhibitions, CFC strengthening, etc. during the financial year 2022-23. Subsequently, an amount of ₹118 lakhs was released as part of this sanction.

2.In the financial year 2023-24, as per Government Order read 3rd paper

above Government accorded Revised Administrative Sanction for this project at an estimated cost of ₹ 2,65,00,000 (Rupees Two Crores and Sixty Five Lakhs only) and sanctioned the release limiting to an amount of ₹ 200 lakhs (Rupees Two Hundred Lakhs only). As part of this, as per Government Orders read as 4th & 5th above, an amount of ₹ 150 lakhs were released during 2023-24.

3. The Member Secretary, BPT, Thiruvananthapuram as per letter read as 6th paper above has recommended and forwarded a project proposal of Handicrafts Development Corporation of Kerala Ltd. for the re validation of Administrative Sanction of the project proposal of New product development, Office automation, CFC strengthening under the Scheme 'Rejuvenation and Revival of Viable Public Sector Units' for an amount of ₹140 Lakh from the current year's(2024-25) budget provision under the H/A 6851-00-190-98-(P).

4. The Working Group Meeting of Industries Department held on 29.05.2024 considered the above project proposal and recommended to accord Administrative Sanction for a total estimated cost of ₹1,26,50,000 (Rupees One Crore Twenty Six Lakh and Fifty Thousand only) from the plan fund limiting the expenditure to this year's budget provision under the H/A- 6851-00-190-98 (P)
