**ORDER**

The Director of Industries and Commerce, Thiruvananthapuram has recommended and forwarded the Project proposal “Conducting Craft Bazars and Exhibition-cum-Sales of Handicrafts in and outside State” submitted by Handicrafts Development Corporation of Kerala Ltd., under the scheme “Assistance to Apex Organisations in Handicrafts Sector” at an Estimated cost of Rs.50 Lakhs from the current year's budget provision under the H/A 4851-00-104-99(P). The components of the project are as shown below

2. The Working Group Meeting of Industries Department held on 06.10.2016 considered the project proposal and recommended to accord Administrative Sanction for an amount of Rs.50Lakhs from the current year's budget provision subject to the following conditions.

- (i) As the plan write up for the scheme "Assistance to Apex Organisations in Handicrafts Sector" under the H/A-4851-00-104-99(P) does not support this project the disbursement should be done only after the H/A is converted to Revenue Head (2851).

- (ii) Handicrafts Development Corporation of Kerala Ltd., should conduct 7days Exhibition cum Sales exclusively for the Artisans from the State in the same space and infrastructure created after the conclusion of Craft Bazaars and Exhibitions as per DCH norms.
- (iii) Handicrafts Development Corporation of Kerala Ltd., should furnish detailed report on the sales generated in these Craft bazaars and Exhibitions and the revenue to Handicrafts Development Corporation of Kerala Ltd., and arrange proper documentation of the exhibitions and keep it as a database for use in future.

3. Government have examined the recommendation of the Working Group and are pleased to accord Administrative Sanction for the project " Conducting Craft Bazaars and Exhibition-cum-Sales of Handicrafts in and outside State" submitted by Handicrafts Development Corporation of Kerala Ltd., under the scheme "Assistance to Apex Organisations in Handicrafts Sector" at an Estimated cost of Rs.50Lakhs (Rupees Fifty lakh only) from the current year's budget provision subject to the following conditions.

- (i) Handicrafts Development Corporation of Kerala Ltd., should conduct 7days Exhibition cum Sales exclusively for the Artisans from the State in the same space and infrastructure created after the conclusion of Craft Bazaars and Exhibitions as per DCH norms.
- (ii) Handicrafts Development Corporation of Kerala Ltd., should furnish detailed report on the sales generated in these Craft bazaars and Exhibitions and the revenue to Handicrafts Development Corporation of Kerala Ltd., and arrange proper documentation of the exhibitions and keep it as a database for use in future.

4. As the plan write up for the scheme "Assistance to Apex Organisations in Handicrafts Sector" under the H/A-4851-00-104-99(P) does not support this project, the Director of Industries & Commerce shall furnish necessary proposal, based on the condition (i) of the recommendation of Working Group Meeting, for release of fund by meeting the expenditure from Revenue Head (2851) after suggesting necessary modifications / additions in the respective Head of Accounts.


