Sub: Covid-19 –Exemptions for essential industries

- Ref: 1. Government of India, Ministry of Home Affairs Order No: 40-3/2020-D  
dated 24/03/2020  
2. Government of Kerala, Department of Disaster Management,  
G.O. (Ms) No.13/2020/DMD dated 26/03/2020

Please refer to Ref 1 wherein, Government of India has imposed a complete lockdown of the country for 21 days from 25<sup>th</sup> March 2020, to contain the spread of corona virus infection. In this regard as per Section 5 (a) and (b), exceptions are given to certain industries from lockdown. These industries are essentially involved in the manufacturing of food, medicines, raw materials for medicines and other essential items.

Vide Ref 2 cited above, Government of Kerala has notified certain industries as essentials exempting from the lockdown (copy enclosed). Further, it is felt necessary to provide specific exceptions are twenty industrial establishments (copy enclosed) to operate continuously to ensure non-disruption of supply of essential items to Kerala Medical Services Corporation Ltd (KMSCL) for the containment of Covid-19 in the State.

In this regard, you are requested to facilitate smooth functioning of these industries to avoid any disruption of supply of essentials by issuing necessary instructions to District Police, local bodies concerned and other Government authorities to allow them to function without any disruption of supply of food and other essential items. In case if any specific industries are to be exempted, you may bring this to the kind notice of the Government for issuing necessary orders.
