### ORDER

Government as per the G.O read as first paper above have accorded administrative sanction for mobile phone allowance to Industries Extension Officers of the Directorate of Industries Department at the permissible rate of Rs 840/- per month by meeting the expenditure from the H/A "2851-00-001-93-IIP" for increasing the efficiency of office communications internally and externally.

2. The Director of Industries and Commerce as per the letter read as 2<sup>nd</sup> paper above has informed that the benefit granted as per the above G.O could not be utilized as the approval for mobile phone allowance at the rate of Rs 840/- per month, was received at the end of the last financial year. Moreover, care needs to be taken to ensure that each post has a permanent telephone number for facilitating communication. Hence it has been requested to procure SIM Cards for officers of Industries Department.

3. Government have examined the matter in details and are pleased to accord administrative sanction for availing BSNL Plan (CUG- Plan 280) for the distribution of low tariff BSNL SIM Cards to the Industries Extension Officers and General Managers of Industries Department such that each post of these officers has a permanent mobile phone number at which the officer can be contacted, at a total cost of Rs 8,23,032/- (Rupees Eight Lakh Twenty

Three Thousand and Thirty Two Only) (yearly recurring) by meeting the expenditure from the H/A '2851-00-001-93-(P)' from the current years budget provision.
