ORDER

- iii. *The procedures prescribed in Circular No. 84/08/Fin dated, 09-12-2008 and Circular No. 75/09/Fin dated, 29/08/2009 should be scrupulously followed.*

iv. *Utilisation Certificate as per form 44 KFC along with component wise expenditure statement should be furnished in due course"*

4. The Director/Additional Director, Industries & Commerce will draw and disburse the amount to Managing Director, Kerala Artisans Development Corporation Ltd., for the implementation of the project.


