ORDER

As per G.O read as 1st paper above, Administrative sanction was accorded for the project proposal “Setting up of Common Facility Service Centre for Bell metal cluster at Kunjimangalam, Kannur” submitted by Handicrafts Development Corporation of Kerala Ltd., under the scheme “Establishment of Common Facility Service Centre” for an amount of Rs.18Lakh meeting the expenditure from the H/A-2851-00-104-86(P).

- (ii). Funds shall be utilised for the purpose for which it is released and not diverted for any other purpose.
- (iii). The procedures prescribed in Circular No. 84/08/Fin dated, 09-12-2008 and Circular No. 75/09/Fin dated, 29/08/2009 should be scrupulously followed.
- (iv). Utilisation Certificate as per form 44 KFC along with component wise expenditure statement should be furnished in due course

4. The Director/Additional Director, Industries & Commerce will draw and disburse the amount to Managing Director, Handicrafts Development Corporation of Kerala Ltd., for the implementation of the project.


